# **Application to Dedicate State land as Road**

## Land Act 1994

### Requirements

- 1. Use this application form to apply to dedicate state land as road.
- 2. Please read the respective <u>applying to dedicate state land as road guide</u>, which includes application restrictions. The content on this page may help you decide if this application form applies to you and your needs. It will also help guide you through the application process.
- Payment of the prescribed Application fee per title reference. A refund of application fees will not be given. Details of fees are available on the <u>Department of Natural Resources and Mines, Manufacturing and Regional and Rural</u> <u>Development</u> website or contact your nearest <u>business centre</u> or call 13 QGOV (13 74 68).
- 4. Part A online form: Contact and land details or Part A Contact and land details (PDF) will need to be completed and submitted with your application.
- 5. You must **attach a drawing** showing the required information which is detailed in the <u>guide</u> under the heading "How to Apply".
- 6. Any additional information to support the application.
- 7. Your application will not be considered as having been properly made unless all parts of this application form have been completed accurately, otherwise your application may be returned to you to complete.

#### Important information

- 8. For detailed information and to ensure you complete the correct application form, we encourage you to arrange a prelodgement meeting and refer to the *Land Act 1994*. Contact your nearest <u>business centre</u> to arrange a meeting.
- 9. When a road is set aside and dedicated as road, the land is open as a road for public purpose.
- 10. You may also be required to pay a purchase price for the dedication of state land as road and provide a plan of survey.
- 11. For opening and closing of road simultaneously refer to <a href="Part B Form LA20: Simultaneous Road Closure and Opening">Part B Form LA20: Simultaneous Road Closure and Opening</a>.
- 12. If you require the dedication of freehold land as road do not use this application. Contact the relevant local government.

#### Information and Data collection

13. Information on this form, and any attachments, is being collected to process and assess your application under section 94 of the <u>Land Act 1994</u>. If required, we may need to consult with third parties such as relevant local or state agencies and adjoining property owners. Details provided to third parties will generally be limited to type of application, area applied for and intended use. Your personal information will not otherwise be disclosed unless authorised or required by law.
